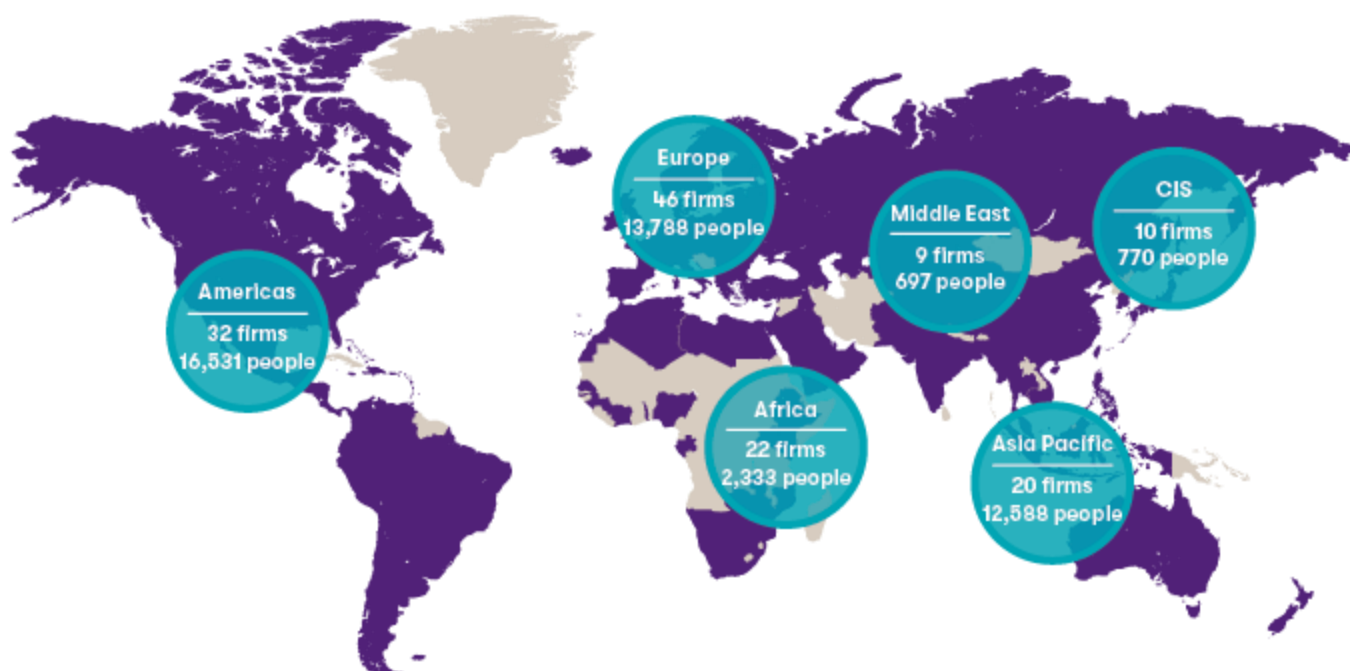

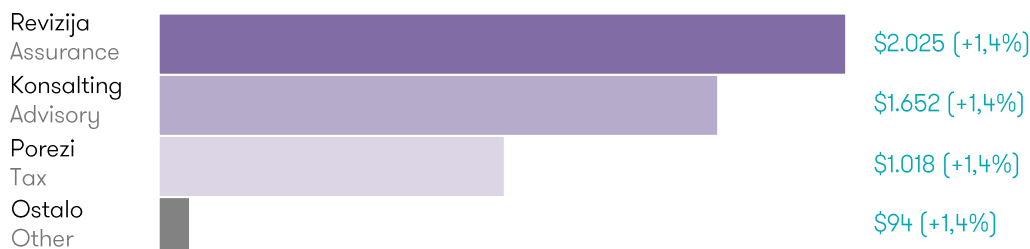

Poreski sistem Srbije je izuzetno kompleksan i predmet čestih izmena, pre svega kao rezultat pristupanja Srbije EU.

Serbian tax legislation is very complex and subject to frequent changes, primarily due to process of harmonization with EU.

Promene za posledicu imaju prilično nejasne zakonske odredbe, visok stepen dvosmislenosti kao i pogrešne primene u svakodnevnoj poslovnoj praksi.

Pravilna primena pozitivnih poreskih propisa predstavlja preduslov za eliminisanje poreskih rizika, ali istovremeno omogućava i optimizaciju poslovnih procesa kao rezultat primene poreskih podsticaja koji su predviđeni poreskim zakonodavstvom Republike Srbije. Sa druge strane, redovno praćenje i tumačenje poreskih propisa uz redovno poslovanje postaje sve veći izazov.

Regarding environmental matters, the report should contain details of the current and foreseeable impacts of the operations on the environment, health and safety, water use, air pollution etc.

Social and employee related matters refer to gender equality, working conditions, social dialogue, health and safety at work etc.

Regarding human rights, anti-corruption and bribery, the statement could include information on the prevention of human rights abuses and instruments to fight corruption and bribery.

Statutory auditors and audit firms should check that the non-financial statements or the separate report has been provided and that the information included are verified by an independent assurance services provider..
